STATUTORY INSTRUMENT

No. 37 of 2010

REGULATIONS made by the Minister of Finance in exercise of the powers conferred upon him by section 96 of the General Sales Tax Act (No. 49 of 2005), and all other powers thereunto him enabling.

(Gazetted 17th April, 2010.)

1. These Regulations may be cited as the

Short title.

**GENERAL SALES TAX (AMENDMENT)
REGULATIONS, 2010,**

and shall be read and construed as one with the General Sales Tax Regulations, 2006, which are hereinafter referred to as the principal Regulations.

2. The principal Regulations are hereby amended by the addition of the following as new Regulation 53 immediately after Regulation 52:

Addition of

**General
penalty.**

“53. Every person who, without lawful excuse (the onus whereof shall be on him), contravenes or fails to comply with a requirement under these Regulations commits an offence and, unless a higher penalty is specifically prescribed, shall be punished on summary conviction with a fine of not less than five thousand dollars and not exceeding ten thousand dollars or with imprisonment for a term not exceeding two

years or with both such fine and term of imprisonment.”

Repeal and replacement of Third Schedule.

3. The Third Schedule to the principal Regulations is hereby repealed and replaced by the Schedule to these Regulations headed “**Third Schedule**”.

Repeal and replacement of Fourth Schedule.

4. The Fourth Schedule to the principal Regulations is hereby repealed and replaced by the Schedule to these Regulations headed “**Fourth Schedule**”.

Commencement.

5. The amendment made by Regulation 2 of these Regulations [General penalty] shall come into force on the 19th day of April, 2010, while the amendments made by Regulations 3 and 4 shall take effect from the 1st day of April, 2010.
